**TREASURER'S REPORT:** Wientjes reviewed the balance sheet and profit and loss report. After discussion, it was Moved-Seconded (Genereaux-M.Trasmondi) to approve. Motion carried.

**ITEMS FROM RESIDENTS:** Beartooth sign repair - Williams answered he and M. Trasmondi are currently repairing the sign to keep it the brown color and small size that is currently throughout our development. Attorney review of legal description for correctness

Section 5.4 Signs - Attorney review for use of city code and keeping the 9' square foot maximum and add that the HOA can put up signs.

Section 5.7 Fuel Storage - Delete and refer to city code? Have attorney review. Section 10.2 Building Height - change to a maximum of 35 feet vertical height per city code.

Section 10.10 Sheds - Refer to City code but keep the sentence - The color of the shed shall match the house color.

After lengthy discussion, it was Moved-Seconded (Kelvin Lower - Joe Genereaux) to approve and adopt the revised covenants with attorney review. All members voting aye. Motion carried.
